
Load Restraint



COURSE OVERVIEW:

This non-accredited training course is run to the NTC (National Transport Commission) Load Restraint Guide 2018 and provides direction on meeting the performance standard and the legislative loading requirements that apply in South Australia, New South Wales, Victoria, Queensland, the ACT, and Tasmania.

This course covers legal responsibilities and obligations, engineering facts on load restraint, and methods of safely restraining and transporting vehicle loads. It provides crucial knowledge for those involved with loading, unloading, and transporting cargo/freight.

COURSE DURATION:

Approximately 4-6 hours, dependent upon participant skill, knowledge and class numbers. Please enquire at time of booking.



COURSE CONTENT:

Assessment is based on theory questions as well as simulated practical scenarios and includes:

- 1. Explanation of law and knowing your obligations
- 2. Hazard and risk identification and control
- 3. Personal protective equipment (PPE) requirements
- 4. General principles of load restraint
- 5. Types and limitations of restraints
- 6. Choosing and identifying correct restraint tools
- 7. Correct lashing points
- 8. Calculating restraint angles and capacities
- 9. Restraint of heavy equipment
- 10. Discussion of common industry problems

DELIVERY METHOD:

- This unit contains both theory and practical elements.
- Blended training:
 - Face-to-face on the job
 - Classroom based
 - Option of self-paced theory assessment prior to practical assessment.

ENTRY REQUIREMENTS:

 - Identifying and comprehending relevant mathematical information in relation to equipment operating capacities.
- Photographic identification must be provided on the day. ID must contain photo, signature, date of birth.
- PPE: Participants are required to wear personal protective equipment whilst attending this course, including hi-vis shirt or vest; long trousers; safety boots, safety glasses; or as per onsite requirements.
- Participants are to source own vehicle/trailer and cargo, or cost of hire is added to course fees.

QUALIFICATION OUTCOME:

Successful students will receive a digital Statement of Attendance for Load Restraint from Regional Training Contractors of South Australia.
