**DUTY OF CARE** 



Loadshifting - Front End Loader Backhoe (LB); Excavator (LE); Front End Loader (LL); Front End Loader Skid Steer (LS); Bulldozer (LZ).

Non-Loadshifting - Roller (RS); Grader (GS); Water Cart (WC); Wheeled Tractor Safety (WTS); Haul Truck (HS).

#### **DUTY OF CARE OVERVIEW:**

Plant Duty of Care assessments are designed to cover the safe use and operation of specified plant and equipment in South Australia. These assessments are for experienced operators who require independent validation of their skills, or for the employer who requires ticketing for their employees in accordance with meeting Work Health and Safety Regulations.

This course is assessment only. Participants must have a minimum of 15 hours experience in the piece of plant they wish to be assessed in, and a third-party report may be used to verify this.

# **LOCATIONS:**

RTCSA delivers Duty of Care assessments, at worksites throughout regional South Australia, Western Victoria and South-Western NSW.

# **COURSE CONTENT:**

Assessment is based on theory questions as well as simulated practical scenarios and includes:

- Conduct routine checks
- Plan work
- Check controls and equipment
- Shift loads
- Shut down equipment
- Secure site

# **DELIVERY METHOD:**

This assessment contains both theory questions and practical assessment. (Blended Training: Face to face onsite/workplace; classroom based. Option of self-paced theory assessment prior to practical assessment).

## **COURSE DURATION:**

Course duration will vary as to participant skill, knowledge, experience, and machine availability. Please allow between 2-4 hours to complete.

# **DUTY OF CARE**

### PRICE:

### ATTENDEE NUMBERS:

Minimum: 4 assessments per day.

Maximum attendee numbers will vary as to the participant skill and knowledge and the number of machines available. This will be discussed with the client at the time of enquiry.

# ENTRY REQUIREMENTS incl. PPE and EQUIPMENT:

- Participants must be 18 years of age or older.
- Language, literacy and numeracy skills that are required for this course include:
  - Being able to identify and interpret information from workplace procedures, documentation, legislation and regulations.
  - Using equipment operating capacity schedule to confirm safe weight load limits.
- Photographic identification must be provided on the day. ID must contain photo, signature, date of birth.
- PPE: Participants are required to wear personal protective equipment whilst attending this course, including hi-vis shirt or vest; long trousers; safety boots, or as per site requirements.
- Participants are to source own machine or cost of machinery hire is added to course fees.

### **LEARNING RESOURCES:**

Study Resources: Learning resources will be supplied either by email, or at commencement of training.

### ASSESSMENT OUTCOME:

Successful participants will receive a Duty of Care certificate and wallet-sized card issued by RTCSA and verifying that they have met the requirements commensurate with the National Guidelines for Occupational Health and Safety Competency Standards for the operation of Load Shifting Equipment and other Types of Specified Equipment [NOHSC 7019 (1992)].
